Society of American Archivists Council Meeting May 20-22, 2019 Chicago, Illinois

Consent Agenda: Ratify Council Interim Actions (Prepared by Executive Committee Member Erin Lawrimore)

BACKGROUND

Current parliamentary policy agrees on validating board decisions made remotely, and ratifying the Council's online and conference-call decisions via the Consent Agenda does not conflict with any existing SAA policy.

DISCUSSION

Given the Council's use of an e-mail discussion list to function as a group and make decisions remotely, approving interim Council actions via the Consent Agenda contributes to streamlining the group's work and improves access to the interim decisions of SAA's elected decision makers.

RECOMMENDATION

THAT the following interim actions taken by the Council between February 28, 2019, and May 9, 2019, be ratified:

 Appointed Dr. Meredith Evans to complete the full term of SAA Vice President/President-Elect Michelle Light (2018-2020), to take effect upon <u>Light's resignation</u> on May 15, 2019. (February 28, 2019)

Support Statement: Appointing Evans to fill the vacancy created by Michelle Light's resignation as Vice President/President-Elect (2018-2020) will help to ensure the continuity of the organization as the Council and staff take on an ambitious three-year Strategic Plan. In the absence of an SAA President from May 15, 2019, to August 5, 2019, Vice President/President-Elect Evans will preside at meetings of the Executive Committee, the Council, and the membership and will perform such duties as may be directed by the Council. Evans will accede to the presidency on August 5, 2019, will present a presidential address at the 2020 Annual Meeting, and will serve as immediate past president of SAA on the SAA Foundation Board of Directors in 2020-2021. (The latter position will remain vacant in 2019-2020.) Legal counsel has advised that this action is within the purview of the Council as provided in the SAA constitution and bylaws.

Society of American Archivists Council Interim Action April 17, 2019

Petition to Form New "Professional Writing Virtual Section" (Prepared by Michelle Ganz, Rebecca Hankins, Alison Stankrauff, and Josh Kitchens)

BACKGROUND

To request Council approval for a new virtual section: The Professional Writing Section (PWS). The section will serve as a pilot for the concept of a "special-interest discussion group."

This proposed virtual section grew out of a series of conversations held over a number of years and with a number of people, i.e. archivists, librarians, and others who are interested in the fundamentals of writing for publishing, in all of its forms. Those conversations yielded a number of important issues: many of our colleagues want to write professional pieces but don't have the foundational skills or know where to start; some need help staying motivated and getting their ideas to print; and others know that professional publishing is important but don't really know where they "fit" into current support structures. After submitting a survey to SAA members and getting overwhelmingly positive feedback, we created a proposal for the PWS for submission to the SAA Council. After conversing with Nancy Beaumont, we came to a resolution that this section would be the perfect inaugural real-world test of the concept of "special-interest discussion groups" that the Council considered when refining member affinity groups in 2016.

DISCUSSION

The PWS special-interest discussion group will give members the opportunity to assist published and aspiring authors throughout SAA to have both a supportive environment, structured advocacy to assist with writing, and guidance to successfully complete their publishing goals. A s meeting at the Annual Meeting is not necessary for this type of group. Informal and off-site activities will be organized for members in lieu of a business meeting. The non-traditional nature of this group is the perfect way to test out a non-traditional format. The tremendous support received for the group shows that there is clearly a need for support, but not how that support needs to be administered.

Purpose of Professional Writing Special-Interest Group:

o To support the SAA Strategic Goal 3.3 of enhancing professional knowledge through partnerships and collaboration and Strategic Goal 4.1-4 meeting member needs.

- To create an environment conducive to supporting new and novice writers through the professional publishing process, and to provide resources accordingly. See appendix A for a partial list of publication platforms and formats.
- o To connect the SAA Publications Board with interested writers.
- o To connect regional archival publications with interested writers.
- o To seek out and provide specialized support for marginalized voices.

Need for the Group:

- o There is currently no regular/centralized place for new or novice writers to connect with people in a similar situation and more seasoned writers for support and counsel.
- The new special-interest discussion group would allow for easy access to peer reviewers, co-authors, and a single clearinghouse of resources currently located in sections like SNAP, the *American Archivist* portal, and across the SAA website in various locations.
- Currently the only way to learn how the process works is to reach out to an individual publisher or editor for guidance. The new section would bring those publishers, editors, seasoned pros, and interested parties together in one spot for ongoing support.
- o To help writers navigate the process of "selling" an article to a publication.
- New professionals need help transitioning from writing papers for school to writing professionally. A new section can provide ongoing support as each new cohort of professionals leave school and join the field.
- People who are transitioning from one field to another or from an institution with support to one without need specialized support that differs from what new professionals do. A dedicated section can provide guidance regardless of career stage.
- o Support for people who need publishing for tenure or certifications.
- A section has the resources to seek out marginalized and outsider voices, nonacademic and non-traditional archivists, and offer specialized support that is otherwise inaccessible.
- o To help writers understand complex issues like copyright and intellectual property.

The focus of the Professional Writing special-interest discussion group is bridging the gap between those who have published and the novices, and guiding people through the mechanics of publishing.

The group recognizes that many people have numerous ideas and prompts that could be turned into publishable works, but they may not have the skill sets to turn these ideas into professional writings. Professional writing is often a skill acquired through educational programs and practice; however, many archivists are not confident in their abilities or skills to work through this process. This group will address these concerns through the following initiatives:

- Basics of writing tutorials and help on the microsite.
- Partnering new writers with a seasoned professionals for one-on-one help.
- Encouraging discussion on, and posing questions to the section list.
- Regular programs like write-a-thons and Writing Challenges

- The Group Will Help with Things Like:
 - How to write an abstract.
 - Providing examples/samples on microsite (member submitted)
 - Providing templates on microsite.
 - Citation Styles and Appropriate Usage:
 - Providing links to standard resources like OWL
 - Providing links to archives-specific standards and resources.
 - How to complete a literature review.
 - Step-by-step guides on microsite.
 - Writing to and/or for a subject specialty.
 - Connecting members who have experience with novice writers
 - A mini-mentoring type program
 - Less structured than the SAA mentoring program
 - Match from pool.
 - Providing specialized support for unique pieces.
 - Allow members to ask for help from the membership at large
 - For example: an archivist writing for a library or medical publication
 - Connecting members to specialized help, resources, or people.
 - Helping writers meet their contract deadlines.
 - By providing regular contact with the membership at large writing will stay at the forefront of people's thoughts
 - Offering suggestions and tips on how to stay on track, on time, and meet your deadlines.
 - Facilitating Peer Review Groups Made Up of Section Members:
 - To be formed of volunteers from the section plus one steering committee member.

Group members will be encouraged to submit to smaller, regional publications, professional blogs, and other innovative types of publications rather than submitting everything to the national SAA publications. See Appendix A for a sample list of journals, blogs, and other publishing platforms. A main goal of the section is to fully identify established and emerging publishing opportunities for members. Additionally, the group will boost calls from SAA Sections for blog or newsletter posts, peer reviewers, or other writing opportunities. Group members will be encouraged to consider alternative formats including poster presentations, annual meeting panels/lightning talks, or educational formats like webinars or workshops. The group will also encourage cross-professional partnerships with librarians, historians, et al, and encourage submissions to partner publications.

The section standing rules, to be determined by the initial steering committee, will clearly lay out procedures future leadership must follow to ensure sustainability of the agreed-upon strategies laid out here.

(Staff Note: Staff recommend a one-year pilot of this "virtual special-interest discussion group" model, to determine the viability of this group format. Upon review in May 2020, the Council can determine if standing rules are necessary for these informal virtual groups.)

Given the unique goals of the group, leaders will build sustainability into the standing rules including things like:

Subcommittees:

- Peer Review Committee:
 - A group of volunteers to be rotated out on a rolling basis
 - Volunteers would serve for 2 terms of one year (with 1/3 of the committee rotating off after one year for the first 2 year cycle)
 - o To be made up of a diverse range of members
 - o Offering basic observations.
- Educational Support Committee:
 - o A group of volunteers led by an elected steering committee member
 - Identify educational needs and opportunities
 - Help secure, promote, and archive online education.
- Outreach Committee:
 - Made up of the section webmaster, one other steering committee member and member volunteers
 - To serve a one year term coinciding with the annual SAA calendar
 - To identify member needs, perform assessments on current or past programs.
- "Help Desk" or "Writers on Call" writers@archivists.com:
 - Model:
 - A staffed help desk accessible via chat on microsite or email (in the style of a task force or steering committee listsery).
 - Reference desk hours where people can submit questions anonymously
 - Set a turnaround time of between 5 minutes and 24 hours.
 - Different from the regular list
 - Specifically for basic and simple questions
 - Can be answered in less than 5 minutes and/or with a link.
 - Potential Staffers:
 - Michelle Ganz

 - Josh Kitchens

- Dara Baker
- Cara Griggs
- Steering committee members

• Ambassador Program:

- Marginalized Voices Ambassador(s)
 - These Ambassadors would be members of one of the demographic groups we are targeting
 - To provide specialized support
 - To ensure that these groups are heard both in the Section, and in the Profession
 - Demographics based, but not Section based:
 - LGBTQ+
 - Women (for whomever identifies as such)
 - Latinx
 - Asian
- Ambassador to Publications Board:
 - A volunteer or steering committee member who would attend the Publications Board meetings at SAA and be the point of contact between the Board and the section.
- Group Ambassadors:
 - Based on the Council liaison model where a volunteer or steering committee member would be assigned to a group of sections (to be determined by the first steering committee).
- Regional Publication Ambassadors:
 - Volunteers from the membership lead by steering committee member
 - Each volunteer is responsible for identifying all of the publications in their region and pass along calls for articles, reviewers, etc.
- International Publication Ambassadors:
 - Two volunteers as part of the publications ambassadors to identify international publications and pass along calls as needed.

Writers Challenge: A regular event that encourages regular writing and good writing habits. The 14-Day Challenge is an opportunity for you to experiment with daily writing, online community, and supportive accountability. It's simple: You commit to write every day for at least 30 minutes. At the beginning of your writing time, you login to our online community, start the timer, complete your writing, and post your progress at the end. You take 5 minutes to support other writers in your group by commenting on their progress.

Write-A-Thon: An annual event that encourages participants to meet goals during a specific period of time.

Writers Challenge: In conjunction with other National Archives Month activities; the Month of October will be the Section's Writer's Challenge. Encouraging members to write for at least half an hour every day in June. The Section will provide motivation, prompts, and recognition (and maybe prizes?) for members who meet or exceed the challenge.

Survey

A survey of the SAA membership was taken to determine the level of interest in a new section. The full results of the survey are in Appendix B.

Summary of results:

42 yes responses within the first 5 hours.

The 100 member threshold was reached within 24 hours of the survey open.

225 yes votes were obtained by the close of the survey 1 week after opening.

RECOMMENDATION

THAT the SAA Council approve a new virtual special-interest discussion group for Professional Writing.

Support Statement: The SAA Council supports professional writers. This new group will help connect writers with the resources they need to successfully publish in professional journals. The group will also help connect national and regional publishers connect with potential new authors. (Note: Because the group is the first considered as a "special-interest discussion group" as part of SAA's member affinity group redesign, its activities and effectiveness, will be evaluated by the Council in May 2020 to determine whether to continue the group.)

Impact on Strategic Priorities: The Professional Writing special-interest discussion group was created with overwhelming support from SAA members and is in line with the Strategic Goals of the Board or Council.

The Section aligns with all of the SAA Strategic Plan 2018-2020:

GOAL 1: ADVOCATING FOR ARCHIVES AND ARCHIVISTS Society values the vital role of archives and archivists.

SAA will:

1.1. Provide leadership in promoting the value of archives and archivists to institutions, communities, and society.

An SAA Section will provide the structure and leadership to support archivists as they promote the value of archives. The Section will provide the support to help foster and promote new SAA Innovators and Leaders.

1.3. Provide leadership in ensuring the completeness, diversity, and accessibility of the historical record.

By supporting marginalized voices through the publications process Section members will be better equipped to advocate for their collections. Publications lead to credibility and strengths proposals through expertise.

1.4. Strengthen the ability of those who manage and use archival materials to articulate the value of archives.

Providing members with the foundational skills needed to write professional strengthens their ability to articulate the value of archives.

GOAL 2: ENHANCING PROFESSIONAL GROWTH Archivists have access to the professional community and resources they need to be successful and effective in their careers.

SAA will:

2.2. Provide content, via education and publications, that reflects the latest thinking and best practices in the field.

Section leadership, utilizing the microsite and listsery, the Section Annual meeting to share information and educational opportunities, both externally created/linked to and created by membership webinars, newsletters, social media, etc.

GOAL 3: ADVANCING THE FIELD Professional knowledge expands to keep pace with an increasingly diverse archival record.

SAA will

3.2. Foster and disseminate research in and about the field.

The number one goal of the Section is to foster and disseminate research in and about the field. Additionally, the Section will support the development of high quality research and professional publication.

GOAL 4: MEETING MEMBERS' NEEDS SAA delivers outstanding service, fosters a culture of inclusiveness and participation, and is proactive and responsive to member needs.

SAA will:

4.2. Create opportunities for members to participate fully in the association.

The Section, by definition, will create opportunities for members to fully participate in the publishing aspect of the Association.

4.3. Foster an inclusive association and profession through greater diversity of membership and expanded leadership opportunities.

A Section designed to foster and support new writers will have the time and resources, like the listserv and microsite, to foster inclusion of marginalized voices.

Fiscal Impact: There is no financial impact on the organization beyond the standard operating costs for a section.
