Petition to Form Accessibility and Disability Section (Prepared by Dr. Lydia Tang)

BACKGROUND

SAA first officially began addressing accessibility with the Joint Archives Management/Records Management Roundtables Working Group on Accessibility in Archives and Records Management in 2010. Since the Diversity Committee was founded in 2012, accessibility/disability is always represented and is featured at the annual Diversity Forum. In 2018, SAA convened a Task Force to Revise the Best Practices on Accessibility. A primary wish of the task force is to continue the professional dialogue about accessibility, which can be accomplished by founding this section.

The topic of disability—for archivists, users, historical documentation, research, and accessibility of services/resources—currently does not have a dedicated section. While aspects of accessibility/disability touch upon other existing sections and are represented within the appointed Diversity Committee, the goal of creating a dedicated section is to ensure that accessibility and disability have a robust and constant presence within the profession. This section would serve as a vehicle for advocacy and provides an open forum for members to exchange ideas and learn from each other.

DISCUSSION

While disability is represented on the appointed Diversity Committee, an appointed group doesn't allow an open forum for the broader membership to have discussions and learn from each other. The hope for this section is that it can be an inclusive community for people with disabilities and allies, where they can learn from each other, compile resources, and showcase work and collections promoting accessibility and disability representation, which is beyond what a single (or couple) of representatives could accomplish on the Diversity Committee. It should be noted that the Diversity Committee is connected with the chairs of the Women Archivists, Women's Collections, Archives and Archivists of Color, Latin American and Caribbean Cultural Heritage Archives, Native American Archives, and Diverse Sexuality and Gender sections. The existence of these sections demonstrates the desire for wider member engagement and have a demonstrated positive impact for the Diversity Committee, SAA, and the wider profession.

While a perennial concern about sections is their continued sustainability, this proposed section has a remarkable level of enthusiastic support from the SAA membership. Within less than 6 hours of the petition's circulation, it reached the 100-member approval threshold and gained almost 300 signatures within the first four days. In the survey, nearly 60 people have indicated that they would be interested in participating in section leadership. While immediately incorporating all interested individuals into a steering committee that large would be impossible, the level of interest and support is impressive and bodes well for sustained and dedicated leadership for many years to come.

Finalizing the section name, reflecting the variety of disabilities and attitudes about it, was challenging. Accessibility and disability can be viewed as a Venn diagram. They are similar, but not equivalent. *Accessibility* can broadly focus on the ability to access but doesn't specifically represent Disabilities. *Disability* by itself can be construed as emphasizing the implied *lack* of ability. The section focus group also responded well to the word *Inclusion* because it can represent how accessibility benefits everyone, including people with temporary disabilities or who are elderly. However, *Inclusion* also has broader meanings beyond the intended scope of the section, and the Diversity Committee is encouraged to consider adding "Inclusion" to their name.

Goals of the Section:

- To be a section dedicated to engaging the archival profession on accessibility topics including archivists with disabilities, users with disabilities, collections representing people with disabilities, and the accessibility of collections, spaces, and workflows.
- To be a supportive community for archives professionals and allies to share their perspectives and fellowship.
 - Potential projects to build the community:
 - To encourage an inclusive and supportive community, the section would need to create a "Community Values" document to provide guidance on disability etiquette and sensitivity.
 - In collaboration with SNAP, the section could support new professionals transitioning into professional positions by creating resources on self-advocacy, surviving and thriving at conferences and other professional events, and practical issues such as transitioning insurance plans.
 - To collaborate with accessibility committees within allied professional organizations such as the American Association for State and Local History (AASLH), the American Association for Museums (AAM), the American Library Association (ALA), and the National Council on Public History (NCPH) to collectively advance accessibility within the GLAM professions.
 - To reach out to disability-focused organizations to encourage people with disabilities to engage with archives.
- To compile and encourage the development of tools, resources, and workflows to improve accessibility within archives.

- Examples of potential projects include:
 - Compile and maintain guidelines, standards, and a bibliography of helpful resources, and
 - Promote and create accessibility-related training opportunities.
- To enable SAA members to learn from each other about emerging accessibility best practices, disability awareness, and other relevant topics with projects such as:
 - Hosting monthly/quarterly open calls throughout the year for members to get to know each other, have mini-presentations on various themes, and collectively troubleshoot issues.
- To showcase and celebrate collections and people with disabilities within the historical record and archival profession.
 - Potential projects:
 - Maintain a directory of disability-related collections and repositories; and
 - Showcase section members and collections through newsletter/blog/microsite profiles and other initiatives.
- To support the Diversity Committee and advocate for disability awareness and sensitivity within SAA at the Annual Meeting, within communication platforms, publications, and other venues.
- To support and offer updates to the Guidelines for Accessible Archives for People with Disabilities as needed and requested by the SAA Council.

RECOMMENDATION:

THAT the SAA Council approve the creation of a new Accessibility and Disability Section.

Support Statement: The formation of this section has been overwhelmingly and positively supported by the SAA membership. The petition reached the 100-member minimum for endorsement within the first 6 hours of circulation and more than doubled by the second day. By the time of this petition submission, 300 positive votes were collected (292 of them being self-reported SAA members in good standing). Comments and feedback were overwhelmingly positive, including the following selected comments:

"As an archivist with disabilities, I have long felt frustrated that there is no formal mechanism for discussing/acknowledging the topic of disabilities in archives (collections, archivists, users) in SAA. I have also been frustrated by accessibility challenges I have encountered attending SAA workshops and events and would appreciate a section being devoted to these issues and working towards making our profession and organization more accessible to all. (I did not join SAA until recently, although I have been involved in

the archives field for almost 10 years because of issues like these.) I fully support this section proposal and would love to be involved!"

"I would like to see this Section highlight and center disabled people's voices (both disabled archivists and disabled archives' users), specifically those who hold other marginalized identities."

"Glad this is happening, because a section like this should have already existed!"

"It is easy to lump this type of work into a group on diversity and inclusion, but I think the way this is written to not only address collections, but spaces as well is a great reason to have a separate section."

"If this section existed I might consider re-joining SAA."

"I wholeheartedly support the formation of an Accessibility Section."

"Wonderful idea to help archivists collaborate to make their repositories more accessible, and to provide a space for archivists with disabilities to voice their thoughts and concerns."

"As a former member of the Task Force on Accessibility, I think it's extremely important to have a standing section that will help members exchange information and advocate for accessibility issues within the field."

"Great idea - we're currently working on making our webpages WCAG 2.1 compliant & it'd be great to have a space to discuss the issues we're facing with others in the same boat!"

Impact on Strategic Priorities:

Goal 1: Advocating for Archives and Archivists

The topic of disability—for archivists, users, historical documentation, and accessibility of services/resources—currently does not have a dedicated section. While accessibility can touch aspects of other existing sections, the goal of creating a dedicated section is to ensure that accessibility has a robust and constant presence within the profession.

Goal 2: Enhancing professional growth

A dedicated section supports and fosters professional growth through educational and outreach opportunities, as well as provides opportunities for archivists with disabilities and allies to develop leadership skills by serving on the section leadership.

Goal 3: Advancing the Field

SAA first officially began addressing accessibility with the Joint Archives Management/Records Management Roundtables Working Group on Accessibility in Archives and Records Management in 2010. Eight years later, SAA convened a Task Force to Revise the Best Practices

on Accessibility. A primary wish of the 2018-2019 Task Force is to advance the professional dialogue pertaining to disability, which can be accomplished by founding this section.

Goal 4: Meeting Members Needs

Accessibility, beyond social justice, is also protected by law and accessibility compliance is something that all institutions grapple with. This section can advocate for accessibility within SAA, inform archivists on best practices to promote accessibility within their individual organizations, and support archivists with disabilities to participate and contribute to the association and profession.

Fiscal Impact: The cost of creating this Section would be the same for creating any new section, in terms of responding to member requests, generating reports to/from SAA Council, competing for other resources/funding within SAA, and the time and attention of the SAA Governance Coordinator. This proposed section would probably plan on meeting online only this year, not requiring a room reservation or dedicated time slot during the Annual Meeting this year.
